# **Highlights**

Total Registration Of Migrant Employees with SLBFE 314,786 Sri in 2024





### **Migration Trends**

By mid-December 2024, over 300,000 Sri Lankans had departed for overseas employment, surpassing previous peak figures and indicating sustained growth in outbound migration.

### **Remittances**

Workers' remittances increased by 10.1%, reaching USD 6.5 billion





### **Major Destination of Sri Lankan Employees**

Kuwait 77,917 United Arab Emirates 52,067 Saudi Arabia 48,020 Qatar 46,639.



Skilled migration accounted for **77.66%** of total registrations,





### **Gender Dynamics**

Male migrant workers increased

to **59.3%** of all registrations, reversing the trend observed in 2023. (186.674 = 2024)

**Female migrant workers,** constituting **40.7%** of the workforce, saw a decline after 2023 (128,112 = 2024)

### **Age Profile**

The majority of migrant workers 16.74% are aged between 30 and 34 years.



### **Recruitment Channels**

Approximately 193,784 workers migrated through private, self-initiated efforts 121,002 workers.
