1. Department Procurement Committee (DPC) on behalf of Sri Lanka Bureau of Foreign Employment invites sealed bids from eligible bidders for the **Proposed Sewage & Wastewater Treatment Plant and Disposal System for Migrant Resources Centre of Sri Lanka Bureau of Foreign Employment at Rathnапura**.
2. Bids should be submitted on the forms available from **Procurement Division of Sri Lanka Bureau of Foreign Employment, No. 234, Denzil Kobbekaduwa Mawatha, Koswatta, Battaramulla from 29.01.2026 up to 17.02.2026** on a payment in cash of non-refundable tender fee of **Rupees Twenty Thousand (Rs. 20,000.00)**.
3. The eligible bidders shall comply with the following qualification criteria.

Eligibility of Bidders

To be eligible for contract award the successful bidder shall not have been blacklisted and shall meet the following requirements:

- Should have registered under the category of Consultant for Wastewater Treatment and related service in 'Central Environmental Authority (CEA)'
- To be registered in Sri Lanka as a company and should have completed 06 years (minimum) experience and to be submitted relevant certification.
- All bidders shall be registered with the Construction Industry Development Authority (CIDA) – Grade C5 or above
- The Bidder should possess a valid certificate issued by the Registrar of Public Contracts in accordance with the Section 8 of Public Contracts Act No 03 of 1987 for every Bid which exceeds Bid price of Rs.5.0 Million.

Qualification requirements to qualify for contract award include:

To qualify for the award of the Contract, bidders shall meet the following minimum qualifying criteria;

- Average annual volume of construction work performed in the last three years shall be at least Rupees 100.0 Million.
 - Successful completion as prime contractor in the construction of a similar nature and complexity with a project value at least Rupees 50.0 Million and completed within 3 to 6 Months, or a higher project value completed within a proportionate time period, completed during last five years.
 - Successful completion of at least 2 units of similar nature and complexity by the institution with private sector or government, completed during last five years.
 - Each of the proposed design team members should have carried out designs within the last 5 years, of at least two works of a nature and complexity equivalent to the task for which they are proposed for.
 - The minimum amount of liquid assets and/or credit facilities, net of other contractual commitments and exclusive of any advance payments which may be made under the contract shall be not less than Rupees 50 Million.
 - Bidder shall submit non collusion affidavit complying with Procurement Manual 2024 as per the attached format together with the bid.
4.  5. Bidding documents may be inspected free of charge at **Manager (Procurement), Sri Lanka Bureau of Foreign Employment, 234, Denzil Kobbekaduwa Mawatha, Koswatta, Battaramulla**.
 6. Bids shall be valid up to 20.05.2026 (91 Days from the date of closing of Bids)
 7. All bids must be accompanied by a bid security of **Rupees 500,000.00** and shall be valid up to **17.06.2026** (119 Days from the date of closing of Bids).
 8. Sealed bids may be delivered to the **Tender Box made available at the Procurement Division of the Sri Lanka Bureau of Foreign Employment, No. 234, Denzil Kobbekaduwa Mawatha, Koswatta, Battaramulla**.
 9. The construction period is **90 Days**
 10. Pre Bid meeting will be held at **10.30 am on 06.02.2026** at 89/6 Vidyalaya Mawatha, New town, Rathnапura.
 11. The deadline for submission of bids will be **11.00 am on 18.02.2026** and will be opened soon after the closing.
 12. Bidders or their authorized representatives are requested to be present at the opening of bids.
