Procurement Notice for the Design, Development, Supply, Installation, Configuration, Commissioning and Maintenance of Software Solution for the Development of a Common Platform to Obtain Online Real-Time Payment Details from Banks

The Chairman, Department Procurement Committee (DPC) of the **Sri Lanka Bureau of Foreign Employment (SLBFE)**, operating under the purview of the **Ministry of Foreign Affairs, Foreign Employment and Tourism**, invites sealed bids from eligible and qualified bidders for **software development services for the Development of a Common Platform for Obtaining Online Real-Time Payment Details from Banks**.

Bidding will be conducted under the **National Competitive Bidding (NCB)** procedure and is open to all eligible and qualified bidders as defined in the **Procurement Guidelines of the Democratic Socialist Republic of Sri Lanka (GOSL)** who meet the qualification requirements stated in the Bidding Documents.

Bidding Documents may be inspected free of charge during office hours on working days from **29.01.2026 to 19.02.2026** at the above address.

Bidding Documents may be obtained from the **Procurement Division, SLBFE**, from **29.01.2026 to 19.02.2026**, between **9.00 a.m. and 3.00 p.m.**, upon submission of a written request on the bidder's letterhead, along with a **certified copy of the Business Registration Certificate**, and upon payment of a **non-refundable fee of Rs. 5,000.00** to the Cashier.

A Bidder should furnish a Bid Security for the value of Rs.100,000.00 along with the Bids which should be valid for a period of 120 days (20.02.2026 – 19.06.2026) from the date of opening of the Bids and be attached with the Bid document.

Successful Bidder / Bidders should furnish a Performance Guarantee equivalent to 10% of the total bid value within 07 days from the date of letter of acceptance. It should be valid for a period of 120 days from the date of letter of acceptance. If you fail to provide software after awarding tender, the performance bond will be encashed in full by the SLBFE without giving prior notice.

Bid Security & Performance Guarantee should be in the form of unconditional on demand guarantees. They may be offered in the form of acceptable bank guarantees issued by a licensed commercial bank operating in Sri Lanka payable to Chairman, Sri Lanka Bureau of Foreign Employment.

Sealed envelopes containing the bids should be clearly marked on the top left-hand corner as: **"Procurement for the Design, Development, Supply, Installation, Configuration, Commissioning, and Maintenance of Software Solution for the Development of a Common Platform to Obtain Online Real-Time Payment Details from Banks – PR/02/12-34"**

Bids should be deposited in the **Tender Box No. 01**, kept at the **Procurement Division, 2nd Floor, SLBFE**, at or before **11.00 a.m. on 20.02.2026**. **Late bids will be rejected.** Bids will be opened immediately after the closing time at the same venue. Bidders or their authorized representatives may be present at the bid opening.

A **Pre-Bid Meeting** will be held at the **Mini Boardroom of SLBFE on 10.02.2026 at 11.00 a.m.**

The Department Procurement Committee reserves the right to reject any bid without assigning any reason thereof and will not be liable to refund any expenses incurred directly or indirectly in connection with the preparation or submission of any bid document.
