



Registration for Korean language special EPS-TOPIK-2026

Instructions for applicants

Eligibility you must complete to get an exam application

1. Age limit between 18 and 39 years (From 28.04.1986 to 27.04.2008)
2. Applicants should not have been imprisoned or severely punished
3. Applicants must have no record of deportation or departure orders from the Republic of Korea. Not staying in Korea illegally for even one day.
4. Applicants should not be subject to a ban on departure from Sri Lanka.
5. Those who have not worked in South Korea for more than 05 years, including the service period under both the E-9 visa category and E-10 visa category.
6. If an employee's service period is extended according to Article No. 18-2 of the Act for Foreign Workers of the State of Korea, if their service period reaches 06 years, they are eligible for this examination.
7. Candidates with color blindness, color deficiency will not be allowed to pass the test.
8. People with spinal cord injury or finger injuries are not eligible to take the EPS-TOPIK exam.

Requirements for obtaining an examination application

Examination Application Fee- Rupees equivalent to US\$ 28 (Rs.8716.40)

When completing the bank receipt,

1. Your name
 2. Address
 3. passport number
 4. National identity card number
 5. Telephone number and the signature mentioned in your passport must be clearly noted.
 6. Receipts that do not mentioned above details will be rejected. Receipts that make cash payments without recording any information will also be rejected.
- Payment receipts must be clearly scanned and uploaded (File Size: 1MB).

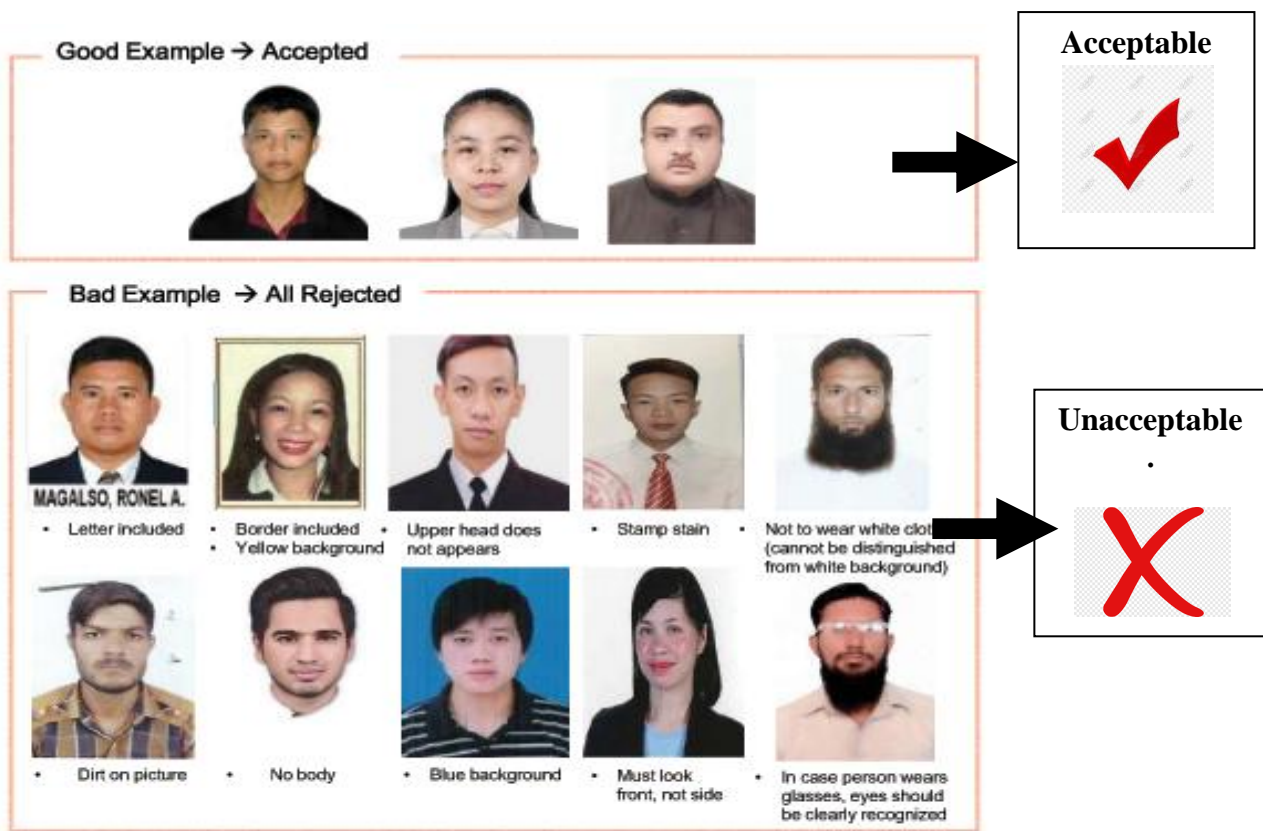
Instructions for Uploading Passport-

- ✚ A scanned copy (JPG Format-1MB) of photo page in your passport. Its validity period should be 06 months.
- ✚ A scanned copy of your passport should be scanned according to the format given below.



Instructions for Uploading Photograph-

- ✚ A clear scanned color photograph of (size 3.5 cm * 4.5 cm) with white background taken within 03 months should be JPG. (Avoid photographing wearing white clothes)
- File Size: 1MB
 - It is mandatory to see your face clearly, and borders, letters, etc. should not be included in the photo.
 - The photo should be taken with the body straight.
 - Photo must be taken without wearing glasses.



Instructions for Uploading Identity Card -

- ✚ A scanned JPG photograph (1MB) of front and back of your National Identity Card.



As the issuance of applications for the examination will be proceed online, please make the arrangements to complete the following requirements and keep those with you.

Applicants with color blindness, color deficiency will not be allowed to pass the test. When you register for the exam, you must get a confirmation from a doctor that you do not have color blindness or color deficiency.

Furthermore, after you pass the exam, you will be tested again for color blindness in the medical examination that is conducted before registering on the Korean job website, and if you are confirmed to have color blindness at that time, your exam results will be invalidated.

If you have the following certificates related to the support training programs conducted by the Korea Human Resource Development Institute, you do not need to pay the examination fees. If it is shown as Admission free above, you do not need to pay the examination application fees.
